**GENERAL FILM, AUDIO, OR VIDEO RELEASE -- Minor**

In consideration of the engagement of the below-named Minor as an actor/actress, I hereby irrevocably grant Awana Clubs International ("ACI") its subsidiaries, affiliates, nominees, successors, licensees, and assigns the right, license, and permission to record and/or reproduce Minor's likeness, and voice on audio or video tape, film or other media (the "Recording"), to edit and otherwise modify such Recording at its discretion, to incorporate the same into a product (the "Work"), and to use or authorize the use of such Recording or any portion thereof in any manner or media or by any means, methods, or technologies now known or hereafter to be known (the "Media") at any time or times throughout the world in perpetuity. I represent and warrant that I am the parent or legal guardian of the Minor named below and have the full power and authority to enter into this Release on behalf of that Minor; that the grant and other provisions of this Release are not in conflict with and do not violate any commitment, agreement, obligation or understanding that Minor now has or will in the future have with any other person or entity; that ACI's use of Minor's name, likeness, voice, and/or other material provided by me will not violate the rights of any person or entity and will not cause ACI to incur any liability for payments to any person or entity; that the Recording does not contain any libelous, obscene or otherwise unlawful material, nor infringe any copyright, whether common law or statutory, nor violate any person's or entity's right of privacy or publicity, nor otherwise violate any personal, property or proprietary rights of any other person or entity, nor contain any instruction or formula that is inaccurate or injurious to the user.

I hereby indemnify ACI, its agents, employees, licensees, directors, officers, assigns and anyone using the Recording or other material provided by me from any and all claims, losses, demands, damages liability, costs and expenses (including reasonable attorneys' fees and costs) arising out of, or in connection with, the preparation of the Recording, the use of Minor's name, likeness, voice or materials in connection with the Recording, or the inaccuracy, alleged breach or actual breach of any representation, warranty or undertaking I have made herein or in the Recording.

On behalf of Minor and myself, I hereby waive all rights and release ACI from, and shall neither sue nor bring any proceeding against ACI, its successors and assigns for, any claim or cause of action, whether now known or unknown, for personal injury, damage to property, defamation, invasion of right to privacy, publicity or personality or any similar matter, or based upon or relating to the preparation or use of the Recording.

You shall not be entitled to any compensation in connection with the unrestricted commercial use of the Work.
